- 2. That Council supports and accepts the proposed scope of option 3(a) as follows:
 - a) Construction of a new access road connecting the existing internal Correctional Centre road network at the eastern site boundary to Occident St Nulkaba (drawing attached)
 - b) Re-sheeting / upgrade of the Occident St road pavement to the Kerlew St intersection.
 - c) The access road is to be of asphalt construction, designed for heavy vehicles with swale stormwater drainage, road lighting and palisade type fencing to neighbouring properties.
 - d) Signage wall and emergency gates.
 - e) Updated way finding signage throughout Cessnock consistent with the existing.
- 3. That Council notes and accepts the scope clarifications as follows:
 - a) The road alignment shown on the enclosed drawing is approximate noting that the final alignment will be determined during the detailed design process following land acquisition, geotechnical investigation and site surveying.
 - b) The proposal is reliant on the voluntary acquisition of NSW Health and private land, at market valuation.
 - c) The proposal does not include: reconstruction of Kerlew Street including the intersection at Occident Street; traffic calming / signage / road closures etc. in Nulkaba, intersection works at Wine Country Drive.
- 4. That Council considers any application lodged in respect of the subdivision of land and/or planning proposal in respect of the zoning of the road, in accordance with legislative requirements; and
- 5. That Council notes the advice provided which outlines that the proposal can proceed as a 'Review of Environmental Factors (REF) under Part 5 of the EP&A Act 1979.
